Notice of Race

Including Amendment 1



The Officers and Members of the Essex Yacht Club invite you to participate in the 73rd Wetherill Race.

The Essex Yacht Club is the Organizing Authority for this event.

The notation “[NP]” in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a). The notation “[DP]” in a rule means that the penalty for a breach of the rule may be less than DSQ at the discretion of the protest committee. This modifies RRS 64.2.

1. RULES

Racing will be governed by:

- 1.1. The current Racing Rules of Sailing (RRS), except as modified herein and/or the Sailing Instructions.
 - 1.1.1. Boats sailing Double-handed may use autopilots. This modifies RRS 52.
 - 1.1.2. Between the hours of sunset and sunrise, RRS Appendix RV: Reduced Visibility Racing Rules, shall apply. This modifies the rules of RRS Part 2.
- 1.2. The current ORC Rating Systems rules and regulations.
 - 1.2.1. ORC Regulation 201.2 does not apply.
- 1.3. The current PHRF Regulations as administered by PHRF of Eastern Connecticut Sailing Association (ECSA).
- 1.4. The current New England Multihull Association (NEMA) Race Rules.
- 1.5. The current US SAILING Safety Equipment Requirements (USSER) for Coastal races, except as modified by 2.2. These requirements are available at <https://www.ussailing.org/competition/offshore/safety-information/ser-world-sailing-special-regulations/>. A copy of these requirements should be kept aboard while racing.
- 1.6. RRS 41, OUTSIDE HELP, is changed by adding: (e) Help in the form of information freely available to all boats, even if that information is only accessible at a cost. “At a cost” help shall not include private forecast or tactical advice, or information customized for a particular boat or group of boats and/or her/their current situation.
- 1.7. [NP][DP] An operational AIS Transponder shall be carried and switched on from the boat’s start until it finishes or is no longer sailing, such that it is receiving and transmitting continuously. The

failure of any station to receive a signal from a boat's AIS Transponder shall not be subject to protest by a competitor or grounds for redress (this amends RRS 60.1 and 62.1(a) and RRS 63.1 shall not apply). A boat whose AIS fails to transmit for more than thirty [30] consecutive minutes may be subject to protest by the Race Committee.

2. ELIGIBILITY AND ENTRY

- 2.1. The race fleet will be divided into separate Divisions for ORC, PHRF, and NEMA scoring systems. The Divisions will be divided into Spinnaker, Non-Spinnaker (NS), and Double Handed (DH) classes where applicable.
- 2.2. Boats shall be at least 29 feet LOA (except as provided in 2.5), have self-righting hulls (except multihulls), shall be properly rigged and ballasted, shall be fully seaworthy and shall comply with the current USSER for Coastal Races, with the following additions:
 - 2.2.1. Each boat shall carry at least one cell phone, the number of which is on file with the Race Committee, and which is kept on and charged while racing and for two hours after finishing.
 - 2.2.2. Each boat shall carry a VHF radio capable of receiving and transmitting on Channels 1005 (05A), 13 and 16
- 2.3. Boats sailing in the ORC Division shall have a current ORC certificate of a GPH of 621 or faster.
 - 2.3.1. ORC DH boats will be scored in a separate class. If less than 3 ORC DH boats are entered, they will be placed in an ORC class using their ORC DH rating.
 - 2.3.2. ORC Rule 200.1 is hereby changed as follows:
 - 2.3.2.1. Other than those boats sailing double-handed, one additional crew under the age of 16 is permitted and shall not count against crew or weight limits.
- 2.4. Boats sailing in the PHRF Division shall have a current PHRF of ECSA rating of 200 or faster.
 - 2.4.1. For entries holding a valid 2025 PHRF certificate from another recognized independent rating authority, the OA will reimburse the cost of obtaining a PHRF of ECSA rating (see Notice Board for details).
 - 2.4.2. If there are 3 or more double-handed non-spinnaker entries they will be placed in a separate DH NS class, otherwise they shall be placed in a PHRF Non-Spinnaker (NS) Class using their NS Handicap.
- 2.5. Multihull boats shall have a minimum length of 26 feet LOA, not including bowsprit, and have a current NEMA Rating Certificate.
- 2.6. Unless authorized by the OA, rating changes will not be accepted after 1200 on Thursday May 15, 2025.
- 2.7. All entries are to be made on-line at www.yachtscoring.com. ***Please note: A completed entry requires, in addition to the skipper's data, the names, emails, emergency contact, execution of a waiver, and Safety at Sea information for all onboard (see NoR 11 & 14).***

3. ENTRY FEES

- 3.1. The entry application shall be accompanied by the entry fee to be paid by credit card or PayPal. The entry fees are based on Length Overall (LOA) which may be rounded downwards to the nearest whole number (e.g. 43.67' = 43')
 - 3.1.1. For entries received and paid before March 1, 2025, the entry fee is \$7.75 per foot.
 - 3.1.1.1. A full refund of the entry fee will be given to one boat selected in a random drawing of all paid entries received before March 1, 2025.
 - 3.1.2. For entries received and paid between March 1 and April 15 the entry fee is \$8.50 per foot.
 - 3.1.3. For entries paid after April 15, the entry fee is \$10.00 per foot
- 3.2. Any boat that introduces a new entrant who successfully starts the 2025 Wetherill race will receive a 40% reimbursement of their entry fee (see Notice Board).
- 3.3. Entries withdrawn before 1800 on Monday May 12, 2025, will be fully refunded.
- 3.4. No entries will be accepted after 1800 on Wednesday May 14, 2025.

4. QUALIFYING SERIES

- 4.1. The Sam Wetherill Trophy Race is a qualifier for the New England Lighthouse series (PHRF).
- 4.2. The race is included as a double-points race in the ECSA 2025 series.
- 4.3. The race is included in the East End ORC Cup series.

5. SCHEDULE

- 5.1. Skippers Meeting will be at 1800 Thursday, May 15, 2025, at the Essex Yacht Club
- 5.2. The first signal will be at 1400 on Friday, May 16, 2025, approximately 0.5 miles west of the Old Saybrook lighthouse.
- 5.3. Time limit will be 1200 on Sunday, May 18, 2025.
- 5.4. All racers are invited to gather for a complimentary continental breakfast at 0900-1100 on Sunday, May 18 at the Essex Yacht Club
- 5.5. The Awards Presentation and Reception will begin at 1700 on Sunday, May 18 at the Essex Yacht Club.

6. SAILING INSTRUCTIONS

- 6.1. Sailing Instructions will be available no later than Monday May 12, 2025
- 6.2. Scratch sheets will be published on www.yachtscoring.com by 1200 on Thursday, May 15, 2025, and will be available at the Skipper's Meeting.

7. COURSE

- 7.1. The course will be from the Start approximately 0.5 nm west of the Old Saybrook lighthouse, leaving R8 to port, then leaving G31 northwest of Gay Head, to starboard, then returning, leaving

Block Island to starboard, R8 to starboard, then to the Finish between the signal boat and the Old Saybrook lighthouse at the outer end of the Connecticut River breakwater.

8. PENALTY SYSTEM

- 8.1. [DP] The Scoring Penalty, rule 44.3, will apply. In the case of a protest involving the rules of Part 2 and OCS, the boat at fault, instead of being disqualified as a result of a hearing, may, at the option of the Protest Committee, have her elapsed time increased by 2%.

9. SCORING

- 9.1. PHRF classes, including double-handed, will use PHRF Eastern Connecticut the time-on-time ratings.
- 9.2. [NP] ORC classes, including double-handed, will be scored using a scoring option available on page 2 of current valid USA ORC certificates. The decision on the scoring option and scoring parameters used for the race, and any subsequent change thereto, will be at the sole discretion of the Race Committee. These will not be grounds for redress by any boat. This changes RRS 60.1(b).
- 9.3. Multihulls will be scored using NEMA time-on-time ratings.

10. PRIZES

- 10.1. The Awards Presentation and Reception will commence at 1700 on Sunday, May 18, 2025, at the Essex Yacht Club.
- 10.2. The Sam Wetherill Race Trophy will be awarded jointly to the two boats in the ORC and PHRF divisions with the fastest corrected times in their division.
- 10.3. The Hot Flash Trophy will be awarded to the boat with the fastest elapsed time in any monohull division.
- 10.4. The Wetherill Club Challenge Trophy will be awarded to the club with the best combined high-point score of any three boats based on their places in their respective classes. (see Notice Board for details)
- 10.5. Class prizes will be awarded to:
 - 10.5.1. First three places for classes with 5 or more entries
 - 10.5.2. First two places for classes with 4 entries
 - 10.5.3. First place for classes with less than 4 entries
- 10.6. If there are insufficient entries for a separate DH class in either the ORC or PHRF divisions, a prize will be awarded to the double-handed boat with the best overall performance in its respective division.

11. SAFETY

- 11.1. [DP] At least 50% of those aboard the boat shall have attended a US SAILING Safety at Sea Seminar after January 1, 2020. Such seminars may be attended online (ussailing.org/) provided at least 30% but not fewer than two members of the crew, including the person in charge, shall have

attended an International Offshore Safety at Sea Course with Hands-on Training or a US SAILING sanctioned In-Person Offshore Safety at Sea Seminar after January 1, 2020. **If the 30% requirement cannot be met due to a “Safety at Sea with Hand-on Training” course not being available, the requirement may, at the discretion of the OA, be met by completing the US SAILING “Online Offshore Safety at Sea” course.**

11.2. All boats are strongly encouraged to follow the STC Safety Guideline for Rendering Assistance.

11.3. Attention is drawn to RRS 1.2 Life Saving Equipment which is modified as follows “The skipper must alert each competitor of their individual responsibility to wear an approved personal buoyancy device and safety harness for the conditions, including but not limited to the following

11.3.1. Between the hours of sunset and sunrise.

11.3.2. When alone on deck.

11.3.3. When reefed.

11.3.4. When the true wind speed is 25 knots or more.

11.3.5. When visibility is less than 1 nautical mile.

11.3.6. With due consideration of the water temperature.

11.3.7. At all times when a boat is being sailed Double Handed.”

12. INSURANCE

12.1. Each participating boat shall be insured with valid third-party liability insurance sufficient to cover liability for loss, damage, personal injury, or death.

13. RISK STATEMENT

13.1. The responsibility for a boat’s decision to participate in a race or to continue to race is hers alone.

See RRS 3, Decision to Race. By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

14. DISCLAIMER OF LIABILITY

Competitors participate in the event entirely at their own risk. It is the sole responsibility of the Skipper/Owner of each boat to see that she is seaworthy in all respects and that she is manned by a competent crew. The Skipper/Owner and all the members of the crew of each boat, by participating in this Race, agree to do so at their own risk, and waive any claim against and hold harmless the Essex Yacht Club, its officers, directors, committees, members, employees, sponsors, and agents against any claims arising in any way out of the participation in the Sam Wetherill Race and related activities of such boat, her Skipper/Owner and crew.

15. PRIVACY POLICY, COMMUNICATIONS AND MEDIA RIGHTS

15.1. As a condition of participating in the race, competitors shall agree to accept operational communications (voice, email, text, or other), and grant the OA, and its agents, employees, sponsors and assigns, the irrevocable right and permission to use basic competitor information, photographs and video footage taken of themselves, their crew and their competing boat, without notification, for use or distribution in any media whatsoever for editorial or advertising purposes or to be used in press information. Competitors shall agree to release, defend and hold harmless the OA and its agents, employees, sponsors, and assigns, from and against any claims, damages or liability arising from or related to the use of the photographs and video footage.
