



## 2026 Newport Regatta

July 10-12, 2026

Sail Newport Fort Adams State Park  
Newport, Rhode Island

*Notation (DP) in a rule in the NOR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification. The notation (NP) in a rule means that a boat may not protest another boat for breaking this rule.*

### NOTICE OF RACE

#### 1 ORGANIZING AUTHORITY

1.1 The Organizing Authority (OA) and Host is Sail Newport.

#### 2 RULES

2.1 The 2026 Newport Regatta will be governed by the rules as defined in the current Racing Rules of Sailing (RRS).

##### 2.2 (DP) US Safety Equipment Requirements (USSER)

2.2.1 All yachts shall minimally comply with the US Nearshore section of the USSER and shall comply with their class rules, where applicable.

2.2.2 USSER 2.4.1 through 2.4.8 regarding Hull and Structure: Lifelines shall apply, except that yachts not normally rigged with lifelines are exempt for these requirements and shall wear approved PFDs at all times while racing.

2.2.3 In the event of a conflict between these Requirements and applicable class rules, the class rules shall apply.

2.3 Class rules which may prohibit the use of VHF radios while racing are waived for the duration of this event for the purpose of safety and for receiving pertinent race information.

2.4 RRS 60.4(a)(2) is changed as follows: "if it alleges a breach of a rule of Part 2 or RRS 31 and is from a boat that was not involved in and did not see the incident, or..."

2.5 For Melges 24 class, IM24CA Standard Coach and Support Vessel Appendix C will apply.

### 3 ADVERTISING

- 3.1 Advertising is permitted in accordance with World Sailing Regulation 20 and the applicable class rules.
- 3.2 Boats are strongly urged to refrain from displaying advertising that may conflict with event sponsors.

### 4 ELIGIBILITY

- 4.1 The 2026 Newport Regatta is open to the following classes who have expressed interest and can achieve the 12 boat minimum: 505, A Cat, Ensign, Etchells, F-18, H12, IC37, ILCA, Melges 15, Melges 24, Shields, Sunfish, Thistle, VX One, Swan 28, 12 Metre, J/70, Snipe, Rhodes 19.
- 4.2 One-Design Classes with a minimum of twelve entries wishing to participate that are not listed on the Newport Regatta website may contact [regattas@sailnewport.org](mailto:regattas@sailnewport.org) to request inclusion in the regatta.
- 4.3 A minimum of 12 boats shall be required for an individual One-Design start.
- 4.4 If the minimum class entry requirement is not satisfied, that class may be canceled or consolidated into a mixed fleet to expedite racing at the discretion of the OA.
- 4.5 (NP) The OA reserves the right to accept entries that may not satisfy these requirements.

### 5 ENTRY

- 5.1 Entries for all boats will be accepted through [online registration on Yacht Scoring](#). Entry includes use of the hoist and dockage for designated classes, racing, Sunday awards reception with food and prizes. Saturday night social tickets are included for skippers and crew. Tickets for additional guests can be purchased on Yachtscoring.
- 5.2 The early entry period runs from March 9 through April 3 at 1159. Entries received after April 3 at 1159 will be subject to standard pricing. Entries received after June 12 at 1159 will be subject to late fees as outlined in NOR 5.5. **Entry fee must be fully paid by April 3 at 1159 to avail of this discount.**
- 5.3 Entry is not considered complete unless accompanied by the appropriate entry fee and all crew have completed a Crew Waiver by the time of sailing.
- 5.4 The OA reserves the right to accept entries beyond stated deadlines.

## 7 MEASUREMENT AND WEIGH-IN

7.1 Measurement requirements will be in adherence to individual class rules.

7.2 Class measurement and weigh-ins will be managed by identified class or local fleet representatives.

## 8 SAILING INSTRUCTIONS

8.1 SIs will be available online by 1700 on July 8.

## 9 COURSES AND RACING AREA

9.1 Racing will be held on Narragansett Bay and Rhode Island Sound.

9.2 The OA will divide the classes into appropriate divisions for optimum racing. Specific course details for individual divisions will be outlined in the sailing instructions.

## 10 PENALTY SYSTEM

10.1 Appendix V will apply.

10.2 In instances where NOR 10.1 conflicts with a class rule, that class rule shall prevail. This changes rule 63.7.

**10.3** The penalty, if any, for an infringement of a rule other than a rule of Part 2 will be at the discretion of the Protest Committee and may be other than disqualification. This changes rule 64.1.

## **11 SCORING**

**11.1** The Low Point Scoring System as described in Appendix A will apply.

**11.2** One race shall constitute a series.

**11.3** A boat's worst finish will be discarded after a class has completed six races. Two races may be discarded if a class completes twelve or more races. This changes rule A2.

## **12 PRIZES**

**12.1** Prizes will be awarded based on the number of entrants for each class.

**12.2** The Dr. Robin Wallace Trophy will be presented to the outstanding boat of the regatta as determined by the OA.

**12.3** The Sally Helme trophy will be presented to the top scoring female skipper.

**12.4** A Sportsmanship Trophy may be presented to a sailor, volunteer, or team who, in the opinion of the OA, best exemplifies sportsmanship.

**12.5** Additional trophies may be awarded at the discretion of the individual classes and/or the OA and may be based on criteria other than scores.

## **13 PERSONAL FLOTATION**

**13.1** The wearing of personal flotation shall be subject to class rules and is highly recommended for all competitors.

**13.2 (NP)(DP)** For the dinghy classes: each competitor must wear a U.S. Coast Guard or equivalent home country authority approved PFD, properly secured at all times, from the time the boat leaves the dock to the time the boat returns to the dock, unless when temporarily adding or removing clothing. Wet suits, dry suits and inflatable PFDs do not constitute adequate personal flotation. This changes rule 40.

## **14 LAUNCHING AND BERTHING**

**14.1** Hoist use is included in the entry fee for classes utilizing Sail Newport Hoists. Dockage is available at Sail Newport's Alofsin Piers on a first-come, first-served basis. Competitors are advised to bring sufficient dock lines and fenders. Please contact Nick Mauprivez (401-266-9885) email: [nick.mauprivez@sailnewport.org](mailto:nick.mauprivez@sailnewport.org) for availability and rates for reserved dock space.

**14.2** For dinghy classes, land storage will be available as directed by Sail Newport staff.

**14.3** Boats intending to arrive at Sail Newport prior to Wednesday, July 8, or stay beyond 1700 on Monday July 13, must make prior arrangements with Sail Newport by contacting Nick Mauprivez by phone (401-266-9885) or via email ([nick.mauprivez@sailnewport.org](mailto:nick.mauprivez@sailnewport.org)).

**14.4** Boats may make alternative arrangements for dockage by contacting the Newport Shipyard (401-846-6000), Newport Yachting Center, Goat Island Marina (401-849-5655), or Casey's Marina (401-848-5945). Mooring arrangements can be made by calling Oldport Marine (401-847-9109) or Newport Harbormaster (401) 845-5815.

## **15 HAUL-OUT RESTRICTIONS**

- 15.1** Etchells and Melges 24 must be in the water by 2000 on July 9. All other keelboats must be in the water by 2000 on July 10.
- 15.2** Keelboats shall not be hauled out during the regatta except in an emergency or with written approval from the Race Committee.
- 15.3** NOR 15.1 and 15.2 shall not apply to the dry sailing classes; these may launch and retrieve using the Sail Newport hoists each day of the event.
- 15.4** Sail Newport staff may be available upon request to assist in the hauling of boats remaining in the water after the conclusion of the event.

## **16 CANCELLATION**

- 16.1** Sail Newport reserves the right to cancel, postpone, or modify the regatta due to weather, insufficient entries, or other circumstances beyond its control.
- 16.2** If the regatta is canceled before July 10, 2026, all entry fees will be refunded in full.
- 16.3** If the regatta is canceled after July 10, 2026, but before any racing has occurred, 50% of entry fees will be refunded.
- 16.4** If racing has begun, no refunds will be provided.

## **17 CODE OF CONDUCT**

- 17.1** All competitors, coaches, and family members are expected to behave in a sportsmanlike manner. This includes behavior both on and off the water including respect for all other persons, personal property of others, the facility, and Fort Adams State Park. Any competitor who violates this trust in any manner, including the consumption of beer or other alcoholic beverage by a minor, may be penalized by the OA and/or have a complaint lodged against him or her to the Protest Committee and/or the appropriate class association. Penalties imposed by the OA and/or the Protest Committee may include disqualification of the boat with which the competitor is associated, notification of law enforcement and/or parents, or other penalties the Protest Committee or the OA may deem appropriate. Any coach or family member who violates this trust may have a complaint lodged against him or her to the appropriate class association.

## **18 EVENT HEADQUARTERS**

- 18.1** Event Headquarters will be in the Sail Newport Main Office, 72 Fort Adams Drive, located in Fort Adams State Park, Newport, RI, 02840.

## **19 MEDIA RIGHTS**

- 19.1** Competitors give absolute right and permission for video footage and photographs of themselves or their boat to be published in any media for press, editorial, or advertising purposes without compensation.

## **20 DISCLAIMER OF LIABILITY**

- 20.1** Sailing is an activity that carries with it an inherent risk of damage and injury. Competitors participate in this regatta entirely at their own risk and are reminded to pay special attention to rule 3, Decision to Race. The race organizers, including the OA, Race Committee, Protest Committee, the State of Rhode Island, sponsors, volunteers, or any other affiliated organization or official, will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of practice for or participation in this event on the water or ashore. By participating in this event, each competitor or parents of a sailor under the

age of 18 agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

## 21 NARRAGANSETT BAY IS A RESTRICTED CHANNEL

**21.1** Restricted Channels: Competitors are reminded that Narragansett Bay and its approaches are considered restricted channels for commercial traffic and other vessels restricted in their ability to maneuver. Competitors must comply with the government right-of-way rules when in proximity to commercial or privileged marine traffic.

## 22 SUSTAINABILITY

**22.1** Sail Newport is committed to reducing our landfill footprint by using alternatives to plastic where possible; encouraging recycling; diverting waste from landfill to compost and educating sailors and the community.

## APPENDIX C

### IM24CA STANDARD COACH AND SUPPORT VESSEL APPENDIX C

*Amended on May 5, 2025*

As per the IM24CA Constitution, Class Sanctioned Event shall mean those regattas organised, co-organised or approved by the IM24CA or in which the IM24CA sanctions the various events to form a series. In IM24CA sanctioned events, Appendix C shall be attached to Notice of Race and Sailing Instructions. In other events, the organising authorities are encouraged to use Appendix C, either partially or preferably in its entirety.

#### SECTION A

- A1** Coach and support vessels shall register with the race office during registration. They shall declare which boat or boats they are attached to.
- A2** Coach and support vessels shall display a numbered flag representing the boat to which it is attached and/or other identification symbol, as may be required by the OA.
- A3** No coach or support vessel shall pass information in any way to a boat that is racing. RRS 41 (outside help) infringements of this will be taken very seriously.
- A4** Coach and support vessel personnel shall not communicate with competitors (by any means) from the warning signal of the first race of the day until the competitor has finished the last race of the day.  
*If the race committee is signalling AP over H, section A4 does not apply until further warning signal.*
- A5** Coach and support vessels shall not go alongside their Melges 24 boats and there shall be no transfer of any goods or equipment until after the finish of the last race of the day.

#### SECTION B

- B1** All Melges 24 boats shall proceed to and from the racing area under their own power.

#### SECTION C

- C1** Coach and support vessels shall keep clear of the racing area at all times during which boats are racing. Except when participating in rescue operations, coach/support vessels shall stay more than 100 meters from any point where a boat might sail during normal racing.
- C2** Any coach or support vessel that interferes with another competitor or the racing in any way, including creating excess wash, or hindering an official vessel carrying out its duties, shall have the competitor(s) to which they are attached, liable to a penalty at the discretion of the jury.
- C3** Any boat may protest under the rules in this attachment.
- C4** The penalty given by the jury is at their discretion. (DPI)

*(Racing: A boat is racing from her preparatory signal until she finishes and clears the finishing line and marks or retires, or until the race committee signals a general recall, postponement or abandonment.)*

#### CHANGES TO THESE RULES

IM24CA standard coach vessel appendix shall not be altered. Any changes for these rules will be the subject for decision by IM24CA Executive Committee.
